200387. Food Waste Pilot Update (B)

Explanation: The City received a grant from the United States Department of Agriculture Community Compost and Food Waste Reduction Project.

The grant is, in part, to determine the fiscal viability of using community composters to collect food waste curbside.

On August 3, 2021, Community Builders provided an update on the project six months into collection operations.

Community Builders conducted a food waste pilot participants survey. The results will be discussed.

210129. Solid Waste Ordinance Updates (B)

Explanation: The Zero Waste Subcommittee has been meeting to discuss various policies related to the reduction, reuse, and recycling of solid waste.

Based on this input, community builders have drafted changes to the City's Code of Ordinances to address the commercial, multifamily, special events, and food waste categories.

On July 20, 2021, the Zero Waste Subcommittee heard a presentation from community builders on proposed changes to the City's ordinance and provided direction on additional changes. The Committee also directed community builders to coordinate a "Town Hall" meeting where neighbors and stakeholders can provide input to possible changes to the Solid Waste Ordinance.

On July 31, 2021, the Zero Waste Subcommittee held a Town Hall to discuss proposed ordinance changes and get input from the community. The Subcommittee requested that Community Builders from the Solid Waste Division and the City Attorney's Office return with an update in a month.

On August 31, 2021, Community Builders presented an update on the ordinance work to date. This included a discussion on penalties for not complying with the ordinance. Additionally, the plastic bag and polystyrene components were discussed.

Community Builders will provide an update at the meeting.
